Todd Family Fun Farm Teacher Information Sheet

Thank you for considering Todd Family Fun Farm for a field trip for your class. While here we want your class to have a great time learning and having fun with agriculture. This sheet is to provide you with information and tips on how to make the day a success. We do have insurance coverage, and some of the rules listed are from state and local associations that we are under. We thank you in advance for your cooperation and we look forward to your visit!

- 1. Please copy the parent permission form for each child in your group. Completed permission forms are mandatory, particularly the permission for use of photos. Since the Fun Farm is a new agritourism operation in west Tennessee, we expect media attention and will not know in advance when media will be at our facility. Without the form signed by parents we are not supposed to let the child have their picture taken by ANYONE (yes, this means even someone with the class).
- 2. All kids must wear tennis shoes or boots to protect their feet.
- 3. Please advise parents and kids to wear pants (NO SHORTS) and bring a jacket if they need to.
- 4. We recommend that your class wear school t-shirts if they have them. This helps us and you keep up with them in case there are other groups here.
- 5. We require each group to have 1 adult per 6 or 7 kids while on the property.
- 6. We have indoor, handicap accessible restrooms with multi stalls.
- 7. Most of our attractions are considered handicap accessible even the maze.
- 8. If you have a child with severe allergies or asthma we encourage you to bring any medication that they made need. We DO have a first aid kit and a nurse here. We are also certified with CPR/First aid. We do not carry any prescriptions or medications and CAN NOT give any to anyone.
- 9. If you choose to eat lunch here, you have a couple of options:
 - a. We have a concessions area and can provide food for your group (Please call Martha for the food options and prices) or
 - b. You can bring a sack lunch. We do have picnic tables for your convenience.
- 10. There will be a concessions and souvenir shop open during your visit.
- 11. Cameras are allowed and encouraged. There are many photo opportunities and we want you to be able to take advantage of them.
- 12. For the fall we offer the following: 7 acre corn maze, pumpkin patch, pig races, hayrides, movie theatre (classroom), ole fashion playground, milk a cow, picture opportunities, and more.
- 13. Schools groups may only have time to do a portion of the maze while here. Within the maze are educational activities to do. Each teacher will have a worksheet that they can take with them back to class. If we can help you in any way with worksheets to use for a week of science, etc. please let us know. We want to help you because this is supposed to be educational, but fun.
- 14. While the group rate is for groups of 20 or more only, school groups will receive the group rate regardless of size. If you have a smaller group, you may end up being scheduled on a day when another group will also be here.
- 15. Reservations must be made a minimum of 1 week ahead of time. (Contact Martha to reserve your spot.)
- 16. We recommend that groups bring sunscreen and bug spray. Children can sometimes get red in a hurry and bug spray may be helpful depending on the time of your visit.
- 17. We do have bus parking.
- 18. Bus drivers are admitted FREE.
- 19. Each child will go home with a goody bag with fun items in it. (School groups only.)
